An international team of ninety scholars is contributing to the online Brill's New Jacoby (2007-2019): a fully revised edition of Felix Jacoby's Die Fragmente der Griechischen Historiker I-III, with new English

translations as well as critical commentaries on all testimonia and fragments together with biographies and bibliographies for each historian. A revised edition, Brill's New Jacoby 2 (2018 - 2026) is now in progress. Each article is substantially rewritten and now includes a new textual apparatus criticus and discussion of the provenance of each fragment, as well as extensively updated texts, commentary, biography, and bibliography.
